

All Grand Officers elected and appointed officers are required to wear your elected or appointed crown and apron, white gloves, purple bow tie, purple jacket or normal masonic black suit, socks and shoes. All other Illustrious Companions must wear the usual clothing of a Royal & Select Master, purple jackets are acceptable if you have one from the Grand Council. There will be onsite registration with a fee of \$15.00. I
