<u>Hotel Information</u>. Reservations can be made by calling 1-800-266-9432. All reservations must be accompanied by a first night room deposit. The room rate is \$ 139.00 plus 16.50% tax plus a \$ 5.00 per night State of Georgia Hotel / Motel fee for single or double accommodations. Debit cards funds are held for 7 to 10 business days by most banking institution. DEADLINE for hotel reservations is Monday, April 10th, 2023. Check in time is 3:00 PM and Check out time is 11:00 AM. Deposits are refundable if the Hotel receives notice of cancellation no later than 72 hours before the scheduled arrival date. COVID-19 Administrative Notes

The protection and safety of our members, attendees, leadership, and staff is our top priority. All attendees will adhere to the following health and safety protocols during the conclave in Atlanta, GA.

1. The wearing of a facemask is OPTONAL AND SUBJECT TO CHANGE. Facemasks and hand sanitizer will be made available to all members. 2. Prior to checking in at the registration desk, you must first visit the Medical/COVID-19 Check-In station. Please DO NOT GO to the registration desk before going to the Medical/COVID-19 Check-In station.

3. All attendees will be asked to provide proof of one of the following: Vaccination card showing full vaccination status against COVID-19 or a Negative COVID-19 PCR or rapid test result, administered by a medical professional and taken within 48 hours of arrival.

4. Daily screening will consist of a current COVID-19 Self-Assessment Questionnaire with a temperature check. Attendees with temperatures above 100.4° F / 38° C will be evaluated for COVID-19 and will not be allowed into the meeting. All attendees will be required to complete a copy of the COVID-19 Liability Waiver and Statement of Understanding. If you answer "YES" to any of the "Symptoms", "Contact", or "Temperature" related questions on the COVID-19 Self-Assessment Questionnaire, you will not be permitted into the meeting and will need a negative COVID-19 test and normal temperature to be admitted the following day. A wristband will be issued to all attendees (daily) after successful completion of the medical screening process.

NO WRISTBAND, NO ENTRY!!!

A wristband is also required to register onsite or to pick up credentials at the advance/onsite registration desk.

5. Temperature checks will be required anytime you leave and return to any of the designated meeting areas. Temperature checks may also be rendered throughout the session or as directed by the presiding officer.
